RULES

Anglers may fish from boats, banks, beaches, rock groins, or bridges.

1. Fishing boundaries are defined as the coastal waters off Edisto, St. Helena Sound, rivers emptying into it, and the adjacent inlets north and south of Edisto. No private saltwater pond fishing is allowed.
2. Fish may be caught on a rod & reel, cane pole or hand line only.
3. Weigh-in is from 4:00- 5:00 on September 28th on our Sunset Deck.
4. In the event of a tie in weight, the fish place in the order they were entered.
5. Any legal angler submitting a fish over/under the SCDNR legal size limit will be disqualified. Size limit for Trout is 14", Redfish size limits are 15"-23".
6. Anglers are reminded that they are fishing this tournament at their own risk.

This is an inshore fishing tournament and in the event of questionable weather, angler is cautioned not to endanger themselves, their crew, or their vessel, by venturing too far from shore. There are plenty of safe places to fish within Edisto, the rivers emptying into it, and the adjacent inlets north and south of Edisto.

All fish must be weighed between 4:00—5:00 p.m. at The Sunset Deck. Fish brought in after 5:00 p.m. will not be eligible for weighing. Anglers with fish must be recognized by the weigh master by 5:00 p.m. to be eligible. This is a member/guest event.

I. MEMBER CONDUCT

Pursuant to and in furtherance of Article XIII of the Constitution and By-laws of the Edisto Island Yacht Club (EIYC) these rules will govern the conduct of members of the club:

1. Members will conduct themselves in a polite, courteous, socially acceptable manner;
2. Members with complaints regarding food or service at the EIYC should refer them to the manager rather than wait staff, bartender, or kitchen staff. More serious complaints should be put in writing and presented to the board of directors.
3. Members will refrain from conduct tending to disparage or circumvent the orderly management of the EIYC.
4. Violation of these rules will be dealt with under the provisions of Article XIII of the Constitution and By-laws of the EIYC.

II. GUESTS

A Family Guest is a member of the member's immediate family.

1. Family guests, ages 21 and over, can use the EIYC clubhouse at any time when accompanied by the member, the member's spouse, or a significant other/domestic partner.
2. Family guests, ages 13 to 23, may use the EIYC's other facilities (docks, ramps and grounds) unaccompanied or accompanied, provided that by allowing any such unaccompanied guest(s) to use said other facilities, the member automatically assumes all liability for such guest's actions.

B. A Non-Family Guest is a guest of a member but is not a member of the member's immediate family. A member, member's spouse, or significant other/domestic partner may bring guest(s) throughout the month, but not the same guest more than one weekend during a given month. It is the member's responsibility to sign-in and accompany their guest(s). A non-family guest must leave the EIYC facilities when the member leaves.

C. Member's spouse or significant other/domestic partner is not considered a family guest and may attend the EIYC without a member in attendance. For the purposes of the EIYC, a significant other/domestic partner is someone who has lived with a member for at least six (6) months, does not own any other primary residence*, and can provide a driver's license or state/federal identification card showing EIYC member's address as his/her residential address. *Primary residence is the legal residence of an individual for the purposes of income tax calculation, acquiring a mortgage, or voter's registration.

D. Members who are single may bring one guest at any time with no restrictions on the same guest.

E. The maximum number of guests who may be brought by any 1 member from Memorial Day through Labor Day will be 8. Outside of the busy season (Memorial them. Day-Labor Day) up to 15 guests per member will still be allowed.

F. The club requires that guests be placed on the tab of the member* who has brought the guest. The member will be responsible for paying the bill using one form (type) of payment (ie. cash or credit card). A member may ask that his or her bill be split evenly among multiple credit cards. If a guest of member pays their own tab, a 15% upcharge will be applied to the tab.

*Member shall include a member's spouse.

III. PARKING GUIDELINES

- A. Pull straight into the lane, aligning with the concrete tire stops/curbs.
- B. Do not leave excessive space between cars.
- C. When parking underneath the clubhouse, park in the deepest space available to allow parking behind your vehicle.
- D. For special events or heavily attended functions, carpool with other members when possible.
- E. Member parking is the priority. Guests are to park off-site or ride with their host member.

IV. CLUB RENTAL

- A. The EIYC facilities cannot be rented during normal operating hours.
- B. The EIYC facilities can only be rented by an EIYC member.
- C. An appropriate rental fee will be determined by the EIYC manager or commodore based on the purpose of the event, time of the event, number of guests, and type of services and facilities needed.
- D. No beverages of any kind may be brought into EIYC facilities by the renter, guests or hires and all drinks must be purchased from the EIYC bar and bartender(s) at the established prices.
- E. A rental agreement must be agreed to and signed by the renting member and the EIYC manager or House Committee chairperson prior to the rental.
- F. The renting member is responsible for insuring that all terms of the rental agreement are adhered to and assumes responsibility for the conduct of all guests.

V. ALCOHOLIC BEVERAGES

- A. The EIYC has the necessary ABC on-premises consumption permits for beer, wine, and liquor as well as a liquor liability insurance policy. All members and guests must comply with the state laws regulating the same.
- B. No alcoholic beverages of any kind, other than unopened 950 mL bottle(s) of wine, may be brought into the EIYC clubhouse by a member, spouse, family member or other guest(s). The wine bottle(s) must be checked in at the bar and a standard corkage fee will apply to all opened bottles of wine. All other alcoholic beverages must be purchased from the EIYC bar and bartender at the established prices.
- C. South Carolina alcoholic beverage laws make seller requirements to license holders. The State is concerned with driving under the influence of alcohol and places added responsibility and liability on the EIYC. The following rules will be strictly enforced:
 - 1. No intoxicated person will be served alcoholic beverages.
 - 2. No one under the age of 21 will be served alcoholic beverages.
 - 3. No one under the age of 21 will be allowed to sit at the bar at any time when the bar is serving alcoholic beverages.
 - 4. No one under the age of 21 will be allowed to consume alcoholic beverages on the EIYC premises.
 - 5. Alcoholic beverages consumed on the EIYC premises during EIYC operating hours must be purchased at the EIYC bar.

VI. PETS

- A. Dogs or other animals are not allowed in the EIYC clubhouse.
- B. When on EIYC property dogs or other animals must be on a leash or carried.
- C. It is the responsibility of each pet owner to clean up after his/her pet.

VII. CLUB FACILITIES AND GROUNDS

- A. Smoking, use of electronic cigarettes, or vaping is prohibited inside the EIYC clubhouse. The use of tobacco or smoking in any form is not permitted on EIYC grounds including the parking areas and the walkway between the restaurant and deck.
- B. There will be no swimming off the EIYC docks at any time. Fishing is allowed with caution.
- C. In the interest of safety, children under the age of 13 must wear a life jacket when on the EIYC docks or slips.
- D. There shall be no merchandise sold for the personal benefit of any individual on the EIYC premises during operating hours without the consent of the Board.
- E. No political or business materials shall be posted or displayed on EIYC property at any time.

VIII. RECIPROCITY

The Edisto Island Yacht Club is a member of the Yachting Club of America (YCA) and welcomes guests from other YCA member clubs. Reciprocity guests must have a membership card or correspondence from their home club to be admitted. They must sign the Edisto Island Yacht Club guest book by providing their name and home club information. Reciprocity guest visitors are limited to three visits to Edisto Island Yacht Club per year.

IX. FEES

- A. Initiation Fee: There is a \$1,000 initiation Fee for new members.
- B. Application Fee: There currently is a 500.00 application fee.
- C. Minimum Fee: Each member must spend \$600.00 annually on food and beverages only by December 31st. This minimum does not include sales tax and tips. Merchandise is not included in the minimum fee requirement. Members who fail to meet the minimum fee will be billed for the delinquent amount, including a \$50 per month late fee.
